Dear Colleagues:

We are pleased to extend the Call for Proposals for Australia's Partnerships for a Healthy Region Initiative.

This Initiative is a five-year AU\$ 620 million package that is part of Australia's renewed effort to help build resilient and equitable health systems in the Pacific and Southeast Asia, support partner countries to reduce disease risks, and build stronger, more equitable, national health systems. The new package aims to better support nations to anticipate and control communicable diseases, prevent non-communicable diseases, advance sexual and reproductive health and rights, and build stronger, more equitable, national health systems.

The bulk of the funding (AU\$350 million) is allocated to communicable diseases and immunization, infection control, disease surveillance, and antimicrobial resistance. Crosscutting priorities of the Initiative also include gender equality, disability and social inclusion (GEDSI), climate change, and community engagement. It will also support projects which reflect and embed Australia's approach to First Nations (i.e., Indigenous Peoples of Australia) engagement.

Australia will also fund research and development (R&D) for vaccines, drugs, and diagnostics for diseases, mosquito control technologies relevant to the Pacific and Southeast Asia and will expand regional health assistance provided by key Australian agencies, and extend partnerships with international and regional agencies that support health systems.

Proposals on product development and access and prevention and control of noncommunicable diseases will be accepted by the Australian Department of Foreign Affairs and Trade (DFAT) until April 20, 2023, 5:00 PM (AEST). We are pleased to inform you that Australian Foreign Minister Penny Wong and Minister for International Development Cooperation and the Pacific Pat Conroy announced the Australian Government's Partnership for a Healthy Region Initiative on 23 February 2023.

The Initiative is a five-year AU\$620 million package to improve health outcomes and promote regional prosperity and stability, and is part of Australia's renewed effort to help build resilient and equitable health systems in the Pacific and Southeast Asia, support partner countries to reduce disease risks, and respond effectively to health emergencies.

The Initiative builds and expands on the previous Indo-Pacific Health Security Initiative for the period 2017-2022. The new package aims to better support nations to anticipate and control communicable diseases, prevent non-communicable diseases, advance sexual and reproductive health and rights, and build stronger, more equitable, national health systems.

The bulk of the funding (AU\$350 million) is allocated to communicable diseases and will fund programs for immunization, infection control, disease surveillance, and antimicrobial resistance. The remainder will expand Australia's assistance to tackle non-communicable diseases via funding for health promotion campaigns in areas such as alcohol, tobacco control, and mental health, as well as screening for conditions such as cervical cancer, heart disease, and diabetes.

Cross-cutting priorities of the Initiative also include gender equality, disability and social inclusion (GEDSI), climate change, and community engagement. The Initiative will also support projects which reflect and embed Australia's approach to First Nations (i.e. Indigenous Peoples of Australia) engagement.

Australia will also fund R&D of vaccines, drugs, and diagnostics for diseases, mosquito-control technologies relevant for the Pacific and Southeast Asia and will expand regional health assistance provided by key Australian agencies and extend partnerships with international and regional agencies supporting health systems in the region. In particular, strategic partnerships and projects and product development and access partnerships will be awarded through competitive processes.
